ISSUE OF 4,682,872,029 NEW UNITS PURSUANT TO THE RIGHTS ISSUE

Unless otherwise indicated, all terms and references used herein shall bear the same meanings ascribed to them in the offer information statement dated 24 December 2020 issued in connection with the Rights Issue (the “**Offer Information Statement**”).

Further to the announcements dated 18 January 2021 and 19 January 2021 in relation to the results of the renounceable and non-underwritten rights issue (the “**Rights Issue**”) of up to 4,682,872,029 new units (the “**Rights Units**”) in Lippo Malls Indonesia Retail Trust (“**LMIR Trust**”), LMIRT Management Ltd., in its capacity as manager of LMIR Trust, wishes to announce that it has issued an aggregate of 4,682,872,029 Rights Units, bringing the total number of issued units in LMIR Trust (“**Units**”) to 7,609,667,047 Units.

The Rights Units will, upon allotment and issue, rank *pari passu* in all respects with the existing Units in issue as at the date of issue of the Rights Units, including the right to any distributions which may accrue prior to the Rights Issue as well as all distributions thereafter

The Rights Units will be listed and quoted on the Main Board of Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) with effect from 9.00 a.m. on 22 January 2021.
