## ANNOUNCEMENT

### COMPLETION OF ACQUISITIONS OF PALEMBANG SQUARE AND TAMINI SQUARE

#### 1. Completion of Acquisitions

Further to:

- (i) the announcement by LMIRT Management Ltd., in its capacity as manager of Lippo Malls Indonesia Retail Trust ("**LMIR Trust**", and as manager of LMIR Trust, the "**Manager**") dated 10 October 2012 in relation to, among others, the entering into of the conditional sale and purchase agreements in respect of:
  - (a) Palembang Square, a four-level retail mall located in Palembang, South Sumatra, Indonesia ("**Palembang Square**");
  - (b) Palembang Square Extension, a one-level underground retail mall located in Palembang, South Sumatra, Indonesia (the "**Palembang Square Extension**");
  - (c) Tamini Square, a seven-level (including two basement levels) strata-titled retail mall located in Jakarta, Indonesia ("**Tamini Square**"); and
  - (d) Kramat Jati Indah Plaza, a five-level (including one basement level) retail mall located in Jakarta, Indonesia ("**KJI**"); and
- (ii) the announcement by the Manager dated 15 October 2012 in relation to the completion of the acquisitions of Palembang Square Extension and KJI,

the Manager is pleased to announce the completion of the acquisitions of Palembang Square and Tamini Square.

With the completion of the acquisitions of Palembang Square and Tamini Square (the "**Acquisitions**"), LMIR Trust's portfolio has been enlarged and now comprises 14 high-quality retail malls and seven retail spaces located within other malls located in Indonesia.

#### 2. Financing of Acquisitions

The Acquisitions are wholly-financed from the proceeds raised from the issuance of the S\$200,000,000 4.88% Notes due 2015 and S\$50,000,000 5.875% Notes due 2017 pursuant to the S\$750,000,000 Guaranteed Euro Medium Term Note Programme established by LMIRT Capital Pte. Ltd. (a wholly-owned subsidiary of LMIR Trust), as announced by the Manager on 26 June 2012.
