PT Lippo Karawaci Tbk ("LK") has a deemed interest in 100% of the shares (the "Shares") of LMIRT Management Ltd. (the "REIT Manager"). Prior to this notification, the Riady family held indirect shareholdings in LK of more than 25% through a family trust.

Pursuant to a reorganisation of the Riady family's ownership in LK (the "Reorganisation"), all the Riady family's direct and indirect interest in LK has been distributed to PT IAP. As a result of the Reorganisation, on 21 December 2017, PT IAP directly held 14.05% interest in LK and indirectly held 20.44% interest in LK through various listed and unlisted subsidiaries. On 25 January 2018, certain subsidiaries of PT IAP transferred 9.51% interest in LK to PT IAP so that PT IAP directly holds 23.56% interest in LK and indirectly holds 10.93% interest in LK through various listed subsidiaries. PT IAP is therefore deemed to be interested in LK's interest in 100% of the Shares. The REIT Manager is

controlled by Peninsula Investment Limited, which in turn is controlled by LK.
