## ANNOUNCEMENT

### ISSUE OF UNITS TO MANAGER IN PAYMENT OF MANAGEMENT FEES

LMIRT Management Ltd, as manager of Lippo Malls Indonesia Retail Trust (“**LMIR Trust**”, and as manager of LMIR Trust, the “**Manager**”) wishes to announce that 4,669,810 new units (“**Units**”) in LMIR Trust have been issued to the Manager on 30 November 2018. The Units were issued at an issue price of S\$0.2676 per Unit, in payment of the base fee component of the Manager’s management fee (“**Base Management Fee Units**”) for the period from 1 July 2018 to 30 September 2018 (“**3Q 2018**”).

Pursuant to the trust deed constituting LMIR Trust, the issue price of the Base Management Fee Units was determined based on the volume weighted average traded price for a Unit for all trades on Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) in the ordinary course of trading on the SGX-ST, for the last ten business days of the relevant period in which the Base Management Fee accrues.

Following the above issue of Units, the total number of Units in issue is 2,859,933,585 of which the Manager’s holding is 178,557,533 Units.
