## FITCH DOWNGRADES LIPPO MALLS INDONESIA RETAIL TRUST TO 'BB-'

LMIRT Management Ltd (the "Manager"), the manager of Lippo Malls Indonesia Retail Trust ("LMIR Trust"), wishes to announce that Fitch Ratings Singapore Pte Ltd ("Fitch") has today downgraded LMIR Trust's Long Term Issuer Default Rating (IDR) to 'BB-', from 'BB'. The Outlook is Negative. Its USD250 million senior unsecured notes due 2024, issued by LMIR Trust's subsidiary, LMIRT Capital Pte Ltd, have also been downgraded to 'BB-', from 'BB'. The downgrade reflects Fitch's expectation that LMIR Trust's financial metrics will remain weak for a prolonged period, as the recovery in Indonesia's retail sector is taking longer than initially estimated.
