FITCH DOWNGRADES LIPPO MALLS INDONESIA RETAIL TRUST'S RATING TO 'C'

LMIRT Management Ltd. (the "Manager"), the Manager of Lippo Malls Indonesia Retail Trust ("LMIR Trust"), wishes to announce that Fitch Ratings Singapore Pte Ltd ("Fitch") has downgraded LMIR Trust's Long Term Issuer Default Ratings (IDR) to 'C' from 'CC'. Its senior unsecured notes due 2024 and 2026, issued by LMIR Trust's wholly owned subsidiary, LMIRT Capital Pte. Ltd., has also been downgraded to 'C' from 'CC' with a recovery rating remaining at 'RR4'.

The downgrade follows LMIR Trust's announcement on 25 January 2024 that the tender offer for its senior unsecured notes due in 2024 and 2026 would proceed and in Fitch's view, such a tender offer constitutes a distressed debt exchange, as the transaction will lead to a material reduction in original terms of the notes.

The Manager wishes to highlight that LMIR Trust remains in compliance with its financial covenants.
