## FITCH DOWNGRADES LIPPO MALLS INDONESIA RETAIL TRUST'S RATING TO 'C'

LMIRT Management Ltd. (the "Manager"), the Manager of Lippo Malls Indonesia Retail Trust ("LMIR Trust"), wishes to announce that Fitch Ratings Singapore Pte Ltd ("Fitch") has downgraded LMIR Trust's Long Term Issuer Default Ratings (IDR) to 'C' from 'CC'. Its senior unsecured notes due 2024 and 2026, issued by LMIR Trust's wholly owned subsidiary, LMIRT Capital Pte. Ltd., has also been downgraded to 'C' from 'CC' with a recovery rating remaining at 'RR4'.

The downgrade follows LMIR Trust's announcement on 21 May 2024 that the exchange offer on its USD138.4 million senior unsecured notes due 19 June 2024, subject to the satisfaction of the conditions in the offering memorandum, would proceed and in Fitch's view, such an exchange offer constitutes a distressed debt exchange, as the transaction will lead to a material reduction in original terms of the notes.

The Manager wishes to highlight that LMIR Trust remains in compliance with its financial covenants.
